DIRECTIONS

"Tersan" 1991 Turf Fungicide should be used only in accordance with recommendations on this label.

"Tersan" 1991 Turf Fungicide is recommended for use as a spray for the control of Dollar Spot, Brown Patch, Fusarium Blight and Pink Snow Mold. "Tersan" 1991 provides both curative (eradicant) action and residual protective action.

Apply recommended amounts in sufficient water to obtain thorough coverage, usually 10-22 L/100 sq. m. When treating golf greens, always treat aprons and approaches.

TURF DISEASES

Dollar Spot (Sclerotinia homoeocarpa)--Apply "Tersan" 1991 at rate of 30 g/100 m2 at earliest appearance of disease. Repeat at 2 week intervals or when disease begins to reappear.

Brown Patch (Rhizoctonia solani)--Apply "Tersan" 1991 at rate of 60 g per 100 m2 at earliest appearance of disease and continue at 10 to 14 day intervals as long as needed. When conditions are unusually favourable for development of disease, reduce interval to 5 to 7 days.

Pink Snow Mold (Fusarium nivale)

B.C. AND EASTERN CANADA

Fall Protection: Apply 60 g per 100 m2 at first sign of disease. Repeat two weeks later if disease persists.

Over Winter Protection: Apply 125 g per 100 m2 during November.

A second application in early spring at 60 g may be needed if infection re-appears.

NOTE: Where Melting Out, (Leaf Spot, Blight) (Helminthosporium spp.) are a problem, apply "Tersan" LSR Turf Fungicide two or three times in the early spring at rate of 90-125 g/100 m2. at 7 to 10 day intervals.
