SHAKE WELL BEFORE USE.

"BLAGAL" is a flowable herbicide for use in spring wheat, barley, oats, and mixed grain to control annual broadleaf weeds, including some which are hard to kill with MCPA alone. Weeds which are well controlled are:

TIMING AND RATE:

Apply "Blagal" to spring wheat, barley, oats or mixed grain when the crop is in the 2 to 5-leaf stage. Best weed control will be achieved when the weeds are small and actively growing, and before the weeds have 5 leaves. For best results on Canada thistle, delay application until wheat, barley and oats have reached the 5-leaf stage. Do not apply Blagal before the weeds have true leaves. Make sure the crop is not sheltering the weeds from the spray. If the crop is under stress, (from lack of moisture or extremes of temperature), "Blagal" may temporarily cause a yellowing of the lower leaves of the crop. However, the crop will recover quickly and any subsequent effect on crop growth and yield will be more than offset by the weed control obtained.

Rate: Use 2.25 litres of "Blagal" per hectare. 1 pail (10 litres) will treat 4.4 hectares.

MIXING PROCEDURE:

Partially fill spray tank with clean water, engage agitation system, add the required amount of "Blagal". Maintain continuous agitation, and fill the sprayer with water to the desired level.

Do not use felt filters. Use only metal screen-type filters and nozzle screens which are 50 mesh or larger. If spray solution is allowed to stand for several hours, vigorous agitation is required to re-suspend the material.

APPLICATION PROCEDURE:

Apply "Blagal" using a minimum of 100 litres of spray solution per hectare at pressures of 200-300 kPa. Flat fan spray nozzles (example 6502, 8002, LF-2 65', LF-2 80') are recommended. Good coverage of the weed is essential. Avoid overlapping and shut off spray boom while starting, turning, slowing and stopping, otherwise injury to the crop may result. Do not apply if rain is threatening. Rainfall shortly after application will reduce effectiveness.
