DIRECTIONS FOR USE

GENERAL: For use as a crack and crevice or spot treatment only. Spray surfaces until wet. Do not spray people, plants or pets. Do not allow children or pets to contact treated surfaces until surfaces are completely dry.

INDOOR USE: NON-FOOD AREAS OF DWELLINGS. FOR CONTROL OF cockroaches, ants, silverfish, spiders, saw-toothed grain beetle (exposed stage): Apply as a coarse wet spray to insect breeding places and harbourages and to adjacent exposed surfaces. Also into cracks, crevices and around baseboards and other places where the insects hide, e.g. behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers.

Repeat in 7 to 14 days as needed. Do not contaminate food or house plants or food storage areas. Avoid contamination of food utensils and food preparation areas. Do not use where food is prepared handled or stored.

OUTDOOR USE: Ants, clover mites, crickets, earwigs, fleas, millipedes, sow bugs, brown dog ticks. Apply to infested areas including outside surfaces of screens, doors, window frames, foundations, patios and other places where insects might enter. For ants apply to hills and runways. Repeat as necessary. Do not apply to vegetation. Avoid excessive wetting of plastic, rubber, asphalt surfaces such as tiles and floor coverings.

#### PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

FLAMMABLE: Do not use near open flame. Do not smoke while using. Do not direct spray towards eyes. Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of mist and use with adequate ventilation. Do not use as space spray. Remove pets and cover fish before applying.

FIRST AID: Contact with skin, eyes, or clothing should be avoided. If on skin, wash with soap and warm water. If splashed in eyes, rinse eyes with clean water. If irritation persists, consult a physician. If ingested do not induce vomiting (contains petroleum distillates) but contact a physician immediately. Contains propoxur, a carbonate cholinesterase inhibitor. Atropine is antidotal.
