DIRECTIONS

For SANITIZATION of dishes, glassware, cooking utensils, silverware, bottles, milk cans, dairy and food processing equipment. Clean with suitable detergent, rinse thoroughly, then dip in a sanitizing rinse made with 32 mL of SANI-CIDE to 15 L of water.

For GENERAL DISINFECTION AND DEODORIZATION: hospital wards, sickrooms, operating rooms, refrigerators, lavatories, urinals, hoppers and floors. Clean with suitable detergent and rinse thoroughly.
