Diazinon Commercial Insecticide is a ready to use residual insecticide for the control of a wide range of insects in food establishments, meat packing plants, homes and apartments.

DIRECTIONS:

GENERAL: Application should be made as a coarse spray (using a pressure sprayer with a large orifice to prevent misting). Thoroughly treat cracks, crevices, along baseboards and other localized areas where insects are present. Do not apply to rugs, carpets, draperies, wallpaper or similar material that may be stained. Do not use as a space spray. Surfaces in direct contact with food should be thoroughly cleaned to remove insecticide residues and dead insects after spraying. Do not use in cupboards where food is stored. Repeat applications as necessary to maintain control.

FLY CONTROL IN FOOD PROCESSING PLANTS: Use Diazinon Commercial Insecticide applied as a residual spray to the walls and ceilings of food processing plants early in the season before canning, meat packing or other food processing begins. Repeat applications, if necessary, when plant is not in operation. Spray unloading docks and other outside areas where flies

congregate to aid in control of these pests.

NOTE: Good sanitation and proper disposal of wastes are necessary in any fly control program.

CONTROL OF HOUSEHOLD INSECTS

Cockroaches, Ants, Crickets, Earwigs, Silverfish - Thoroughly treat cracks and crevices, baseboards, spaces around water pipes and tanks, surfaces behind and beneath cupboards, refrigerators, sinks and stoves, around garbage containers and other areas where insects hide. Treatments should be repeated as necessary.

Carpet Beetles in Non-Fabric Areas - Thoroughly treat cracks, crevices, infested areas around baseboards, cracks in the floor and walls and localized areas of floors, under floor coverings, behind shelves and other storage areas.

Clover mites in Buildings - Apply Diazinon Commercial Insecticide around window and door frames, sills, to baseboards and floor space adjacent to them. Treat crack and crevices thoroughly.

Fleas and Brown-Dog Ticks in Buildings - Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floor and floor coverings. Applications should be repeated if re-infestations occur. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

NOTE: When used in dwellings, care should be taken to avoid deposits which children and pets could come in contact with. Care should be taken to avoid spotting of wallpaper and fabrics. Do not contaminate food or feedstuffs, food container or cooking utensils.

NOTE: The solvent used in this formulation is a petroleum distillate which may stain certain plastic, rubber, and asphalt materials such as tiles and floor coverings. Do not treat such materials.

CAUTION: In meat and food processing plants, only spray when the plant is not in operation. No exposed food products, ingredients or packaging materials to be left in the room. Cover food handling equipment. Any treated surface that may come in contact with meat food products or other food products should be washed and rinsed with potable water after spraying and before re-use for food processing.

PRECAUTIONS: KEEP OUT OF REACH THE OF CHILDREN. Treat food processing plants early in the season, before canning and other processing begins. Repeat applications if necessary, when the plant is not in operation. Do not use as a space spray. May be harmful if swallowed, inhaled or absorbed through the skin. Provide adequate ventilation of the area to be treated. Avoid contact with skin, eyes and clothing. Wash all contaminated clothing with soap and hot water before re-use. Avoid breathing spray mist. Wash thoroughly with soap and water after handling. Do not allow children to contact treated areas until thoroughly dry. Do not contaminate food, utensils, food containers, or food preparation areas. Remove pets and cover fishbowls before spraying. This product is toxic to fish and wildlife. Do not contaminate domestic or irrigation water supplied lakes, ponds or streams. Do not use or store near open flame.

FIRST AID: For external contamination of skin; wash with soap and water. If in eyes; flush with plenty of fresh water for at least 15 minutes. If swallowed do not induce vomiting. Obtain medical attention or contact a poison control centre immediately. Never give anything by mouth to an unconscious person.

TOXICOLOGICAL INFORMATION: Diazinon is a cholinesterase inhibitor. If swallowed give stomach lavage. Antidote: Atropine sulphate at 1-2 milligrams every 15 minutes may be necessary.

DISPOSAL: Empty the container thoroughly. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the Manufacturer.
