GENERAL

Propoxur 1% residual insecticide solution is a ready to use formulation for the control of the insects listed including those resistant to certain chlorinated hydrocarbon and organophosphate insecticides. This product drives insects from their hiding places, gives rapid kill and long residual activity.

DIRECTIONS

For use in areas of industrial, institutional and commercial locations where treatment will present no human hazard or contamination of food.

Apply with a low pressure sprayer equipped with a coarse spray nozzle. Spray surfaces only until wet. Avoid excessive run-off. Apply to all insect breeding sites and harbourages. Treat

adjacent exposed surfaces where insects may crawl when they come out of hiding. Applications may be made to floor surfaces along baseboards and around air ducts, however, do not treat entire areas of floors or floor coverings. Repeat treatment as necessary.

COCKROACHES: Treat thoroughly the infested area. Spray baseboards, cracks and crevices; around window and door frames; the undersurfaces of shelves, drawers and work tables; behind and beneath cabinets, refrigerators, sinks, stoves; in and around waste containers, switch panels, floor drains, and other places where cockroaches hide or rest.

ANTS: Apply to trails and place where Ants enter premises such as window and door sills.

HORNETS AND WASPS: Spray directly into the nest at dawn or dusk when all the insects are inside the nest.

EXPOSED STAGES OF ANGOUMIS GRAIN MOTH, CIGARETTE BEETLE, DRUGSTORE BEETLE, INDIAN MEAL MOTH, SAW-TOOTHED GRAIN BEETLE, WEEVILS: Treat thoroughly floors and walls of the infested areas with attention to cracks, crevices, corners and perimeters. Sanitation and dust control are of primary importance. Fumigate or destroy infested products.

SILVERFISH, FIREBRATS, PAPERLICE: Apply localized areas infested by these insects.

CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, CENTIPEDES, SOWBUGS: Spray thoroughly the interior and exterior perimeter of the infested premises. For Clover Mites give particular attention to window sills.

FLEAS, FLIES, GNATS, MOSQUITOES, PUNKIES, SANDFLIES(OUTDOORS ONLY): Spray infested area thoroughly including outside surfaces of screen, doors, window frames, foundations, and other areas where insects may enter.

FOR USE IN MEAT PACKING AND FOOD PROCESSING PLANTS: Use only in the inedible product areas of meat packing plants, including those that are federally inspected. Any exposed food products, equipment or packaging material must be removed or covered before spraying. Rinse all equipment with water before resuming operations. Treat food precessing plants early in the season before canning or other precessing begins. Repeat application, if necessary, when plant is not in operation. Spraying where insects congregate will aid in preventing re-infestation. Good sanitation and proper disposal of wastes is essential in any effective insect control program.

LIMITATIONS

Do not use as a space spray. Provide adequate ventilation of

area being treated. Do not allow children to contact treated areas until surfaces are thoroughly dry. Do not store near feed or food products. Avoid contamination of feed, food processing equipment and food handling surfaces. Do not apply to humans or animals. Remove pets and cover fish bowls before spraying. Do not spray on plants.

PRECAUTIONS: May be harmful if swallowed inhaled or absorbed through skin Avoid breathing of spray mist. Do not get in eyes, on skin or on clothing. In case of contact, wash immediately with soap and water. Wash hands, arms and face thoroughly with soap and water before eating or smoking. Wash all contaminated clothing with soap and water before re-use.

FIRST AID: Contains petroleum distillates. If swallowed do not induce vomiting. In case of poisoning call a physician immediately. Have patient lie down and keep quiet. If on skin, remove contaminated clothing and wash skin thoroughly with soap and water. If in eyes flush with flowing water for 15 minutes.

TOXICOLOGICAL INFORMATION: Propoxur is a cholinesterase inhibitor. Atropine is antidotal. Do not give Morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.

DISPOSAL: Follow provincial instructions for any required cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Conservation and Protection, Environment Canada.
