DIRECTIONS FOR USE

For indoor use only in the manufacture (formulating) of pest control products (PRO-MIX with Biofungicide) solely for export from Canada.

RECOMMENDED APPLICATION RATE: $400g/200m^3$ of peat moss or growing medium. Suspend SubtilexTM in water or nutrient solution (1g/10 - 250ml), apply as spray and mix thoroughly.

PRECAUTIONS

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. May cause sensitisation. Avoid contact with skin, eyes or clothing. Avoid breathing dust or spray mist. Wear a long-sleeved shirt, long pants, shoes plus socks, water proof gloves, eye goggles and a dust/mist filtering respirator (MSH/NIOSH approval number prefix TC-21C) or a NIOSH approved respirator with any N-95, R-95, P-95 or HE filter for biological products when handling, mixing/loading or applying the product and during all clean-up/repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. When using, do not eat, drink or smoke. Keep away from food, drink and animal feedstuffs.

FIRST AID
