DIRECTIONS FOR USE

Stable & Horse Fly Spray Solution is a new ready-to-use oil-base fly-spray specially formulated for use in and around stables and

horse barns. Ideal for application as a fog or mist with conventional spray equipment or electric foggers. Also accepted for direct application as a spray mist to horses and ponies.

For Use in Stables To Kill Stable Flies, Horn Flies and Mosquitoes - Apply as a fog or mist with hand sprayer, power sprayer or electric fogging and misting equipment. Use 200 mL of Stable Spray for 100 m³ of area. Before fogging close doors, windows, and other openings to reduce air movement as much as possible. Then while fogging the spray mist can be applied over and around animals. However, do not apply in areas where animals have received direct application of this material within eight hours.

For use on Horses To Kill Stable Flies, Face Flies, Horn Flies, and Mosquitoes - Apply 30-60 mL as a mist spray with hand or automatic sprayer. Mist the animal thoroughly covering all parts of the body, but do not wet the skin. Do not apply more than 60 mL per animal per day. Apply lightly, particularly where flies are congregating.

PRECAUTIONS

Harmful if swallowed, inhaled or absorbed through skin. Harmful to wildlife if allowed to contaminate lakes and streams. Do not use in milk rooms, milk processing rooms, or dairy barns. Do not use foggers activated by steam pressure. Do not use in poultry houses. Do not use in food storage or processing areas.

Call doctor in case of accident. Keep out of reach of children. Wash with soap and water after handling, before smoking or eating. Wear protective clothing, natural rubber gloves and simple masks or respirator. Destroy used gloves. Clean contaminated clothing before reuse. Do not apply or allow to drift to areas occupied by unprotected humans or animals. Do not contaminate feed or foodstuffs, streams, lakes, ponds, irrigation water or water used for domestic purposes. Do not store with feed or foodstuffs. Store in original containers. Avoid contaminating food-handling utensils. Burn empty containers. Applied with petroleum solvent, may affect plastic, rubber, or asphalt tiles or coverings.

FIRST AID INSTRUCTIONS

Contains petroleum distillates. If contacted, wash skin with soapy water. If in eyes, flush for ten minutes with water. If swallowed, do not induce vomiting. Have victim lie down and remain quiet. Obtain medical attention at once. Contains

petroleum distillate solvent. Aspiration of vomitus may cause serious pneumonitis.

TOXICOLOGICAL INFORMATION

Symptoms of poisoning are weakness, headache, tightness in chest, blurred vision, non-reactive pinpoint eye pupils, salivation, sweating, nausea, vomiting, diarrhea, abdominal cramps. Treat for both Dichlorvos and petroleum distillate poisoning.

For Dichlorvos, Atropine is antidotal. Do not use morphine. Clear chest by postural drainage. Observe patient for 48 hours. Allow no further exposure until blood cholinesterase is regenerated.

For kerosene use gastric lavage if vomiting was not profuse. Sodium sulfate laxative, 6 g / 1 kg by mouth, oxygen therapy if needed, caffeine sodium benzoate intramuscularly if needed, treat for pneumonia that may follow.
