HOUSEFLIES - To control houseflies, use 15 mL Malathion 50E with double that amount of sugar or molasses mixed with each 1 litre of water. Spray thoroughly. Do not use in dwellings or in milk processing rooms. Allow 14 days before applying to freshly whitewashed surfaces.

FRUITS AND VEGETABLES - Malathion 50E controls aphids, mites, thrips, mealybugs, plant bugs, pear slug, pear psylla, leafhoppers, leafrollers, and leafminers. Use 5 to 10 mL of Malathion 50E per 5 litres of water. Do not treat fruits and vegetables within 7 days of harvest.

ORNAMENTAL TREES, SHRUBS AND FLOWERS - Malathion 50E controls aphids, thrips, lace bugs, leafminers, mealybugs, bagworms, spider mites, tent caterpillars, white fly, native scale, pine needle scale, four-lined leaf bug, tarnished plant bug, leafhoppers, European pine shoot moth. Use 5 to 10 mL of Malathion 50E per 5 litres of water. Apply at first appearance of pest and repeat as needed. Malathion may cause injury on the following ornamentals: African violet, Crassula, Ilex, Petunia, Sabina, Canaerti Junipers, Boston, Maidenhair and Pteris ferns.

GREENHOUSE ORNAMENTALS - (Rose, Carnation, Chrysanthemum) Malathion 50E controls aphids, mites, thrips, mealybugs and white fly. Use 2 mL of Malathion 50E for 1 litre of water. Repeat application as necessary.
