DIRECTIONS: Dust liberally over the animal beginning at the head and working back. Be sure powder gets down to the skin, including feet and legs. Do not treat or contact eyes, face or genitals. To prevent re-infestation, applications should be repeated at weekly intervals as needed. For effective flea and tick control, treatment of the pet should be repeated at weekly intervals as needed. For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If the pest problem persists, an insecticidal premise treatment may be required. Wash hands after use.

FIRST AID: If on skin, wash thoroughly with soap and water. If in eyes, flush with water for 15 minutes. If irritation persists, obtain medical attention. If swallowed, induce vomiting. Obtain medical attention or contact a poison control centre. Take container, label or product name and PCP Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Carbaryl is a moderate reversible cholinesterase inhibitor. Atropine is antidotal.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if inhaled or swallowed. Avoid breathing of dust and contact with skin. Do not treat cats under 8 weeks of age. Do not use on nursing females. Do not use on sick cats or cats under drug or pesticide treatment. Consult veterinarian before using on pregnant animals. Repeated application may produce skin or nasal irritation in sensitive cats. If this occurs discontinue use. Do not use near birds, fish, feed, or foodstuff.

DISPOSAL: Do not reuse container. Wrap and dispose of empty container with household garbage.
