To protect the adhesive from dirt and dust, spray it into a tubing about 8cm diameter by 20cm long. Place the "glue board" in areas that the rodent or crawling insect travels, such as along walls and underneath equipment. For Flying Insects, spray a non-absorptive surface such as cardboard and suspend from ceiling. DO NOT PLACE IN DIRECT SUNLIGHT. This product is not ultra-violet tolerant. Check regularly to see if rodents or insects have been trapped. Over a period of time the dust will accumulate on the adhesive making it less tacky. At this time, refurbish the "glue board" by spraying on more adhesive.
