DIAGRAMS

APPLICATION DIRECTIONS:

Apply in late spring or early fall on actively growing weeds. Avoid application during long, dry periods. Do not apply when rain is expected and do not water lawn within 24 hours of spraying. Product acts within a few days and weeds gradually die. Grass fills in as weeds disappear.

DIRECTIONS FOR LOCK-N-SPRAY SYSTEM:

To use the LOCK-N-SPRAY System:

- With tap turned off, connect sprayer to garden hose. (Diagram)
- 2. Peel off sticker from top of LOCK-N-SPRAY container.
- 3. With front label facing you, attach container to sprayer: (Diagram)
- (i) Push up to seal container firmly against sprayer.(ii) Twist container to "LOCK" position.
- 4. Turn on water.
- 5. Rotate nozzle down for soil and lawn application. (Diagram)
- 6. Squeeze (colour) trigger to begin spraying, release trigger to stop.
- 7. When finished, turn the container to unlock and remove from sprayer.

- 8. Flush sprayer with water, squeezing and releasing the trigger in short bursts (2 or 3 times).
- 9. Turn off water, squeeze trigger to release pressure. Disconnect sprayer from hose. Container automatically reseals itself.

PRECAUTIONS:

Re-entry Interval:

Do not allow people (other than the applicator) or pets on the

Maximum Application Frequency: For good turf/lawn management, normally two applications per year per treatment site are adequate. This does not include spot treatments.

FIRST AID:
