SPRAY INFORMATION: To initially prime the sprayer:

1. Place the hose of the sprayer in can and screw down cap.
2. Turn the sprayer nozzle clockwise, as shown, to the fully closed position.
3. Then back the nozzle off two complete turns. This will produce a jet stream. (Remember, sprayer is fully adjustable - from jet stream to fine spray, simply by turning nozzle counter clockwise).
4. Hold the can in one hand and hold it level with the sprayer in the other hand.
5. While holding the sprayer upright in a pistol position, aim towards the ground(avoid spraying grass, plants or other

- desirable vegetation) and squeeze the trigger rapidly a number of times until the product sprays from the nozzle.
6. After completing Step 5, both sprayer and can may be held in any position that is convenient for you.
 7. When not in use, turn the sprayer nozzle clockwise to the fully closed position and keep nozzle above liquid level of can to prevent leakage from nozzle.

DIRECTIONS FOR USE: APPLICATION: Hold can upright and apply as a coarse spray to infested surfaces until wet. For use as a crack and crevice or spot treatment for insects listed below. Do not use as a space spray. Do not spray on pets, humans or plants. Avoid excessive wetting on asphalt, tile, rubber and plastic materials. Do not apply directly to carpets, floor coverings, bedding, clothes or furniture as damage may occur. Remove or cover all food and utensils before treatment. Apply around sinks and drainpipes, workshops and basement areas, storage closets, behind appliances, around house foundations, garbage can areas, patio areas, window frames and doorways. ALL APPLICATIONS MUST BE MADE AS A SPOT-SPRAY ONLY.

COCKROACHES, ANTS, SILVERFISH, CRICKETS, EARWIGS, FIREBRATS, CARPET BEETLES, SOWBUGS, MILLIPEDES AND CENTIPEDES: Apply spray to surface until wet; to areas around water pipes, cracks and crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, baseboards, window and door frames, etc. and similar areas where these insect travel and/or hide. Repeat as necessary.

BROWN DOG TICKS AND FLEAS: Spray infested areas around baseboards, windows and door frames, wall cracks, sleeping areas of pets and localized areas of floor and floor coverings. Repeat as necessary. Place fresh bedding in animal quarters after treatment. Do not treat pets with this product. For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets (N.B. this product is not for use on pets), and treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use and wash the pet's bedding, living quarters, and surrounding areas prior to treatment with this product.

PORCHES, PATIOS, GARAGES AND OTHER AREAS AROUND THE HOME WHERE INSECTS HIDE: To help control crickets, ants, spiders, earwigs and certain other insects, spot-treat areas where the insects congregate.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not permit children or pets to contact sprayed areas until dry. Avoid contact with sprayer dip tube. May cause irritation to skin or eyes. Avoid inhaling spray mist or contact with eyes, skin and clothing. Wash thoroughly after use. Avoid contamination of food, feed, utensils, drinking water or any body of water. Remove or cover all food and utensils before treatment. Wash

contaminated food surfaces, utensils and clothing with soap and water. This product is toxic to fish and crustaceans.

FIRST AID: If swallowed, do not induce vomiting. Call a Poison Control Center and obtain medical attention immediately. If on skin, wash with soap and water. Remove contaminated clothing. If in eyes, flush with water and obtain medical attention.

TOXICOLOGICAL INFORMATION: Contains a cholinesterase inhibitor. Atropine is an antidote.

STORAGE: Keep product in original container and do not store near food, fertilizer, feed or seed. Keep the nozzle above the liquid level in the can to prevent leakage from nozzle.

DISPOSAL: Do not reuse container. Dispose of empty container with household garbage.
