DIRECTIONS:

Cooling Water Systems: For control of bacterial and fungal slime in Industrial Cooling Water Systems add 40-50 mL of Biomate 710 per 1000 L of system volume. Repeat initial dosage until control is evident. When control is established reduce dosage to 5-25 mL of Biomate 710 per 1000 L of system volume. Repeat every 2-5 days or as needed.

ECOLOGICAL:

Open dumping is prohibited. If plastic, do not reuse empty container. This product is toxic to fish and wildlife. Treated effluent should not be discharged where it will drain into lakes, streams, ponds or public water. Do not contaminate water by cleaning of equipment or disposal of waters. Apply this product only as specified on this label.
