LABEL PENTAC WP - Miticide

DIRECTIONS FOR USE:

PENTAC WP is a specific miticide that is very effective against the two-spotted spider mite. In the greenhouse, it is recommended for use on roses, chrysanthemums, gardenias, carnations, azaleas, delphiniums, snapdragons, zinnias and poinsettias. It is also effective on outdoor roses and nursery arborvitae, including hemlock and spruce. PENTAC WP does not kill beneficial insects. It has a long residual activity.

For roses, PENTAC WP should be applied at a rate of 62 g per 100 L of water on greenhouse roses and two applications - insuring thorough coverage should be made about two weeks apart for optimum results. From 400 - 600 mature bushes should be sprayed with 100 L of the mixture.

Because other floral greenhouse crops are grown under cooler conditions, only one 62 g application of PENTAC WP may be required. It is recommended that a single application with thorough coverage be made initially unless the mite problem is severe, in which case two 62 g applications should be made about two weeks apart. A similar single treatment on nursery stocks - including arborvitae - gives excellent mite control.

PENTAC WP is compatible with most other commonly used materials and may be applied from regular greenhouse sprayers.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

DO NOT take internally.

WASH thoroughly after handling.

AVOID repeated skin contact.

AVOID inhalation of spray mist and dust.

AVOID contamination of foodstuffs.

AVOID contact with eyes.

AVOID spraying in greenhouse aquaria containing valuable tropical fish.

FIRST AID

If in eyes: Flush eyes thoroughly with plenty of water. Get medical attention if irritation persists.

If on skin: Remove contaminated clothing. Wash thoroughly with soap and water.

If swallowed: Call a physician or Poison Control Centre. Give patient one to two glasses of water or milk. DO NOT INDUCE VOMITING. Vomiting should be only induced under the direction of physician or the poison control centre.

If inhaled: If gas/fume/vapor/dust/mist from the material is inhaled, remove the afflicted person immediately to fresh air. Seek medical attention if irritation persists.

STORAGE

Store in a dry place. Keep from freezing. Do not contaminate water, food or feed by storage or disposal.

1. Thoroughly empty the contents of the container into the application device.
