DIRECTIONS: SHAKE WELL BEFORE USING. **INDOOR FLYING INSECTS:** Close all windows and doors. Spray upwards with waving motion until room is filled with mist (6-10 secs for average 30 cubic metre room), while backing toward exit and keeping spray about 1 metre away from walls, fabrics and furniture. Keep room closed for 15 minutes. Ventilate sealed areas before re-entry. **FLEAS:** Spray infested areas such as pet's bed and resting quarters. **DO NOT SPRAY PETS.** **CRAWLING INSECTS:** Spray into hiding places such as cracks, crevices, along baseboards and under appliances. **ANTS:** Spray ants, ant trails and entry points. **OUTDOOR PESTS ON FLOWERS AND SHRUBS:** Ornamentals only. Spray with slow, sweeping motion, keeping 30 to 45 cm away from all plants. Avoid wetting - a light spray kills pests effectively. Spray only when air is still and temperature is under 32EC. Do not spray in direct sunlight - early morning or evening is preferred. Use with caution on young plants and new growth.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container, or store at temperatures over 50EC. DO NOT USE ON ANIMALS OR HUMANS. Cover fish bowls and remove pets for one hour when spraying rooms. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Avoid contact with skin, eyes, and clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use on Maiden Hair Ferns. Do not use on vegetable or fruit crops.

FIRST AID: Avoid inhalation or exposure of spray to eyes. In case of contact, flush with plenty of water. If irritation persists, contact a physician. If accidentally swallowed, contact physician or poison control centre immediately. Take container, label or product name and Pest Control Product Registration Number with you, when seeking medical attention.

DISPOSAL: When container is empty, pres button to release all pressure. DO NOT THROW INTO FIRE. Wrap and dispose in household garbage.
