DIRECTIONS FOR USE:

TO CLEAN, SANITIZE AND DEODORIZE CARPETS

Steam Extraction: Vacuum carpet thoroughly. Mix 16 mL of SANEX per litre of water. Inject and extract as you would any steam cleaning shampoo.

Spin-bonnet (Bonnet Buff) Cleaning: Vacuum carpet thoroughly. Mix 32 mL of **SANEX**per litre of water. Spray on carpet at rate of 4.9 - 7.4 L/M2 (alternate direction).

Heavy Spin Bonnet (Bonnet Buff) Cleaning: Vacuum carpet thoroughly. Mix 125ml of **SANEX** per litre of water. carpet at a rate of $4.9-7.4 \text{ L/M}^2$.
