DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the *PEST CONTROL PRODUCTS ACT*, or a fertilizer-pesticide registered under the *FERTILIZERS ACT*.

PRECAUTIONS:
