INSTRUCTIONS

Failure to follow label instructions may result in erratic weed control. Read all directions carefully before applying.

GENERAL:

ENHANCE is a surface active agent which improves herbicidal performance by increasing plant uptake. Enhance is recommended for use with Pursuit(R) in soybeans and for use with glyphosate based formulations for improved quackgrass control.

ENHANCE AND GLYPHOSATE BASED FORMULATIONS (ROUNDUP, LAREDO,

WRANGLER)(1) TANK-MIX INSTRUCTIONS

ENHANCE can be tank-mixed with glyphosate based formulations for improved seasonal weed control. This application is made in the fall or spring prior to seeding the crop.

WARNINGS: Before using, read the glyphosate product label instructions. Do not spray the tank-mix of Enhance and glyphosate bases formulations (Roundup, Wrangler or Laredo) on the crop or any other desirable vegetation. All of the glyphosate product label instructions must be followed.

WEEDS CONTROLLED

Quackgrass (*Elytrigia repens*).

APPLICATION

Apply ENHANCE at 0.5 litres/hectare tank-mixed with ROUNDUP. Wrangler or Laredo at 2.5 litres/hectare. Apply in 100 to 200 litres of clean water per hectare (broadcast basis) using a properly calibrated low pressure herbicide sprayer. Check the sprayer daily to ensure proper calibration and uniform application.

MIXING INSTRUCTIONS

ENHANCE has been formulated for ease of mixing. The following mixing instructions must be followed for best results:

1. Half fill the sprayer tank with clean water.
2. Start agitation.
3. Add the required amount of ROUNDUP and agitate until well mixed.
4. Next add the required amount of ENHANCE.
5. Complete the filling of the sprayer tank.
6. Continue to agitate while spraying.
7. If foaming is a problem, use HALT(R) to control it.

ENHANCE AND PURSUIT(2) TANK-MIX INSTRUCTIONS

Enhance is recommended with Pursuit for early preplant application to emerged weeds and for early postemergence application.

WARNINGS

Before using, read the Pursuit label. All Pursuit label instructions must be followed.

CROP

Soybeans

WEEDS CONTROLLED

See Pursuit label, for broadleaf weed and grass control claims.

APPLICATION (See Pursuit label)

Apply Enhance plus Pursuit plus Liquid Fertilizer to early emerged weeds, but before the weeds reach the 2 true leaf stage. For reduced tillage situations, application may be made up to 30 days prior to planting. Application may also be applied after the crop has emerged. Application to a crop under stress should be avoided.

RATES

Apply the recommended rate of Pursuit in 100 to 400 litres of water per hectare. Add Enhance at 0.25% volume/volume bases (eg. 2.5 L Enhance in 1000 L of spray solution) and liquid fertilizer solution (10-34-0, 28-0-0, or 32-0-0) at 2 L/ha.

MIXING INSTRUCTIONS

1. Fill the spray tank one-half to three-quarters full with water.
2. Start agitation.
3. Using a calibrated measuring device add the required amounts of Pursuit, Enhance and fertilizer solution.
4. Complete the filling of the sprayer tank.
5. Continue to agitate while spraying.

STORAGE

Store above freezing. Avoid contamination of food and feedstuffs.

DISPOSAL:

NON-RETURNABLE CONTAINERS

1. Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection, Environment Canada.

RETURNABLE CONTAINERS

1. Empty container thoroughly. Do not attempt to rinse or open the container.
2. Follow Manufacturer's instructions for any required additional cleaning of the container prior to its return.
3. Do not destroy container.
4. Make the empty container suitable for pick-up and return according to Manufacturer's instructions.
