DIRECTIONS FOR USE: APPLY THIS PRODUCT AS IT IS PURCHASED. DO NOT MIX WITH WATER OR OIL. Use trigger spray attachment enclosed.

INSECT PESTS INDOORS: Apply to localized areas where cockroaches, ants, crickets, firebrats, silverfish and spiders are found or normally occur including dark corners of rooms and closets; cracks and crevices in walls, along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. For ants apply to trails, also around doors and windows and wherever else these pests may find entrance.

NOTE: A period of 4 to 7 days is normally required for maximum affect on cockroaches.

In homes or dwellings, remove or cover all food before application. Do not apply in dwellings where occupants are ill.

For control of carpet beetles, apply spray as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

For control of brown dog ticks, American dog ticks and fleas, apply a spray as a spot treatment to infested areas, such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized area of floor and floor-covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment. DO NOT TREAT PETS WITH THIS PRODUCT.

PESTS OUT OF DOORS: Ants, American Dog Ticks, Brown Dog Ticks, Crickets, Fleas and Earwigs: For treatment of localized infestation of these insects in outdoor areas where there are weeds or brush non-crop areas, spray infested areas thoroughly. Do not use on garden vegetables or fruit crops. For ants, thoroughly treat hills and runways. Repeat application if reinfestations occur.

DIRECTIONS FOR USE OF TRIGGER SPRAY:

- 1. Remove sprayer from re-usable bag. Put on plastic gloves.
- 2. Unscrew cap from container and retain in plastic bag.
- 3. Place tube through hole in cap, then insert tube into bottle and screw on cap.
- 4. Open nozzle about one turn.
- 5. Point sprayer at desired area, and pump trigger until spray begins.
- 6. Adjust nozzle as desired...fine stream for spot treatment, wide mist for broad application.
- 7. When temporarily not in use, keep trigger sprayer above liquid level of container to prevent leakage from nozzle.

- 8. To store, remove sprayer and carefully drain tube into bottle by squeezing trigger. Re-cap container with original cap.
- 9. Rinse sprayer tube and gloves with clear water before storing in the plastic bag supplied.

NOTE: Trigger Sprayer is to be used only for this product.

REMEMBER...ALWAYS STORE PESTICIDES, CAPS, SPRAYERS AND RELATED EQUIPMENT OUT OF REACH OF CHILDREN AND PETS.

USE PRECAUTIONS: Do not apply this product in electrical equipment because of possible shock hazard. Do not use in poultry houses or other animal buildings. Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried and do not apply to areas where they are likely to make frequent contact with the deposit. Remove pets and cover fish bowls(tanks) before spraying.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes, skin and clothing. Avoid breathing vapours or spray mist. Wash thoroughly after handling. Wash contaminated clothing before reuse, destroy contaminated shoes.

FIRST AID:

IF SWALLOWED: Induce vomiting and seek medical attention or call poison control centre immediately.

IF IN EYES: Flush immediately with flowing water for at least 5 minutes. Seek medical attention.

IF ON SKIN: Wash off in flowing water or shower.

TOXICOLOGICAL INFORMATION:

Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine, only by injection, antidotal.

ENVIRONMENTAL HAZARDS: Chlorpyrifos is highly toxic to bees exposed to direct treatment or residue on plants. Spray when bees are not actively foraging. Chlorpyrifos is toxic to fish, crustaceans and birds. Keep out of lakes and streams.

DISPOSAL: Dispose of empty container with household garbage. Do not re-use container.

STORAGE: Do not store below OEC. Store away from food, feedstuffs and domestic water supplies.
