DIRECTIONS FOR USE: THIS PRODUCT CAN BE USED IN DWELLINGS, FARM BUILDINGS, FOOD SERVICE ESTABLISHMENTS, GRANARY BINS (empty), PROCESSING PLANTS (feed food, non-food) AND STORAGE AREAS.

RATS AND MICE: Place the required amount of DIPHACIN LIQUID in a suitable container (a mason jar with a chicken fount over the top is very handy) on a clean level place where rats or mice are accustomed to feeding. Replace the old solution every 5-7 days if necessary; to keep the liquid clean and fresh. For best results, keep the liquid clean at all times. Where continuous infestation

occurs, permanent bait stations will be necessary. Baiting should continue until a complete lack of feeding is noted, which should be from 5-15 days.

#### DISPOSAL

1. Empty the container thoroughly.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product and the clean-up of spills contact the regional office of the Conservation and Protection Service, Environment Canada.
