DIRECTIONS: For Preventive Control of brown patch, dollar spot, copper spot, fading out and melting out, apply Thiram Flowable at the rate of 175 mL/100m² tank mixed with P.M.A.S. Turf Fungicide at the rate of 40 mL/100m². Apply every 7 to 10 days beginning prior to disease appearance and continuing throughout the season. Under warm humid conditions favouring disease development apply every 5 to 7 days.

For Curative Control apply at the rate of 175 mL/100m² tank mixed with P.M.A.S. Turf Fungicide at the rate of 40 mL/100m². Apply at 7 day intervals beginning when diseases are first noticed. Return to preventive schedule when disease is under control.

For control of grey (*Typhula* spp) and pink snow mold (*Fusarium nivale*) apply 375 mL/100m² tank mixed with 75 mL/100m² of P.M.A.S. Turf Fungicide in the fall just prior to the first permanent snow cover. In areas where disease is severe or frequent, repeat during a mid-winter thaw when turf is exposed. To control and prevent spread of the disease under cool, wet

conditions in the spring, make an additional application after the spring thaw using one half the above rates.

For uniform coverage apply in 24-48 litres of water/100m².

NOTE: Do not mow or water the grass within 24 hours of application

Rodent Repellent

Protects nursery stock, fruit trees, shrubs and ornaments against feeding damage caused by rabbits, mice and deer.

SPRAY APPLICATION (Growing season) - Use 945 mL of Thiram Flowable with 6 litres of water and 1 quart of latex sticker*, mix well and apply as a full coverage spray to a point well above the reach of animals. A second application of Thiram Flowable may be necessary under heavy feeding pressure. Apply under favourable drying conditions but when temperature is above freezing.
