Add directly to recommended point of use. Avoid high pH systems which can cause product degradation. For the control of bacterial, fungal, and yeast growths, initial dosages of 250 to 875 mL/tonne of dry pulp of Daracide 6205 are recommended. For the control of bacterial growth in industrial recirculating cooling waters add 4 to 40 mL of Daracide 6205 per 1000 litres of water in the system. See Product Bulletin 62-6205 for further information.

CAUTION: MAY CAUSE INJURY TO THE EYES. MAY BE HARMFUL OR FATAL IF SWALLOWED. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Avoid breathing vapour or mist. Do not take internally. Wash thoroughly after handling.
