DIRECTIONS FOR USE:
3D15 is recommended for the control of slime in cooling

towers/air washers. Add 1-5 packets (55g each) per 4500 L of coolant. The unopened packet should be added at a point in the system, such as the sump or reservoir, where the active ingredients will be uniformly dispersed throughout the coolant. Remove packet from system before the addition of additional packets or after 3 days. Dispose of according to pesticide disposal instructions.

PRECAUTIONS: 3D15 is irritating to skin and may cause burns and allergic skin reactions. Avoid contact with eyes. Do not take internally. Wear goggles and rubber gloves when handling. Avoid using chemical in confined space. Remove clothing that has been in contact with this product and wash thoroughly before reuse. Avoid contamination of food.
