DIRECTIONS: Equipment capable of delivering a pin stream should

be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where the listed insects hide. If reinfestations occur, repeat applications as necessary. Provide adequate ventilation during and after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50 degrees C. Do not spray near open flame or spark. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOOD STUFF, FOOD UTENSILS, FISHBOWLS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. DO NOT CONTAMINATE FOODSTUFFS. Do not use in any area where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboards where food or cooking utensils are stored.

In homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before reuse.

In meat and food processing plants and food service establishments, treat only when plant is NOT in operation. Remove or cover all food packaging materials, and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before resuming operations. Do not use in rooms where milk is processed, handled or stored.

FIRST AID TREATMENT: Contains volatile petroleum distillate. If swallowed, do not induce vomiting. Call physician immediately. Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal.
