DIRECTIONS FOR USE:

Shake well before using. Point valve opening away from face and push button, holding can upright.

FLYING INSECTS:

To control flies, gnats, mosquitoes, and wasps-Close doors and windows. Direct mist upwards to all parts of the room especially windows and other light sources. Spray 6-11 seconds per 30 m3 of space. For best results leave the room closed for 15 minutes after each treatment and before ventilation. Also direct mist into areas where insects are present. Keep spray at least 1 m from interior walls, fabrics and furniture.

CRAWLING INSECTS:

To control cockroaches, ants and silverfish: Spray hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage area. Spray ant trail around door sills and window frames, or in ant nests. Insects must be contacted to be killed.

BED BUGS:

Spray mattress, especially around seams and tufts. Take beds apart, spray all joints. Repeat as required.

Ensure proper ventilation after sealed areas have been treated.

PRECAUTIONS:

Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat. Do not incinerate can or store at temperatures over 50'C. Flammable mixture.
