CONTROL OF COCKROACHES, ANTS, BOOKLICE, CRICKETS, EARWIGS, MILLIPEDES, SILVERFISH AND SPRINGTAILS AND CLUSTERS IN BUILDINGS:

Apply dust to infested places such as cracks and crevices, spaces around water pipes and tanks, surfaces behind and beneath cabinets, refrigerators, sinks, stoves and similar areas where insects hide. Repeat treatment as necessary. When used in dwellings, care should be taken to avoid deposits with which children could come in contact. Do not contaminate food, food containers or cooking utensils.

CONTROL OF SOIL INSECTS: Fungus Gnats (Larvae) and Springtails. Apply to cover soil surface and work into soil 2.5 to 5 cm. Give plant thorough watering. Repeat as required to maintain control.

PRECAUTIONS: Keep out of reach of children. Avoid breathing dust. Wear an approved respirator when handling large amounts.
