DIRECTIONS: Later's Rose & Flower Dust is Ready-To-Use and will control insects and diseases. Controls Rose Aphids, Leafrollers, Thrips, certain Caterpillars, Black Spot, Leaf Spot, Petal Blight, Powdery Mildew and Rust. Open cap and squeeze container to apply a light and even coating to all upper and lower leaves. Do not use within two weeks of an oil spray treatment.

INSECTS: Treat thoroughly when insect damage first appears. Repeat as necessary. For best results, dust in the early morning or late evening when the temperature is low and the air is still.

PLANT DISEASES: Disease control on plants should be preventive so it is best to treat before any damage appears. Start as soon as foliage appears and apply at 7-10 day intervals during the growing season. Treat weekly during moderate infections, or twice weekly during severe infections caused by continuous rain or high humidity.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid inhaling dust. May cause irritation of nose, throat and skin. Avoid contact with eyes, skin or clothing.

FIRST AID: IF SWALLOWED, contact a doctor or poison control center at once. IF IN EYES, flush with water for 15 minutes and get medical attention. IF ON SKIN, wash with soap and water.

ENVIRONMENTAL HAZARDS: Do not use where Bees are foraging. Do not

contaminate any body of water. STORAGE: Keep product in original container. Store in a cool, dry place away from feed and foodstuffs. DISPOSAL: Do not re-use empty container. Wrap container and discard in household garbage.
