Plum Curculio, White Apple Leafhopper - Apply 550 to 850 g/ha of AMBUSH 25WP. Tentiform Leafminer, Green Fruitworm, Apple Maggot, Leafrollers, Tarnished Plant Bug, Mullein Plant Bug, Lesser Appleworm, Codling Moth: Apply 850 g/ha of AMBUSH 25WP.
