No Mustard Algicide is effective in controlling algae in swimming pools. It is especially recommended for green, blue-green and mustard coloured algae growths.

DIRECTIONS FOR USE: Vacuum leaves and any other foreign debris from pool. Brush visible algae from the surface with surface compatible brush. Adjust pool water pH to 7.4 - 7.6 range. Add Guardex Super Chlor, as per label directions, to oxidize water soluble organic wastes. Allow to circulate for 1 hour. Now apply 65 mL of No Mustard Algicide per 10,000 Litres of water. Dilute the concentrate into 5 or more litres of water and apply in areas of greatest circulation. In extreme cases if algae persists, repeat No Mustard Algicide application after 2-4 days. Use Guardex Stain & Scale and Clear-Up to remove residual copper and dead algae after successful treatment. For recurring algae problems, use No Mustard Algicide with a maintenance dosage of 15 mL per 10,000 litres weekly.
