For wireworm control by seed treatment of Wheat, Oats, Barley, Rye, Corn, Beans, Peas, Cucumbers and Sugar Beets. Do not use for treatment of crops other than recommended on this label.

LINDANE may be used as a dust treatment for application by home made rotary drum treater or any SEED TREATMENT equipment that will ensure uniform coverage of seed.
