USES:

Viscide 3321 is a dual-purpose amine-type treatment for both prevention of corrosion and control of microbiological growth in water and hydrocarbon systems.

DIRECTIONS FOR USE:

Dosage depends upon the severity of micro-biological contamination and concentration of corrosive agents present. For extended applications, dosages should be varied dependant on micro-biological counts. For details, consult your Nalco technical representative. Usual dosage ranges are as follows: oil production, salt water disposal and water flooding, 15 to 50mg continuous, 75 to 200mg/L batch. Recirculating systems, 10 to 150mg.

DO NOT USE IN POTABLE WATER SUPPLY

DO NOT MIX AS A CONCENTRATE IN COMBINATION WITH STRONG OXIDIZING AGENTS.

PRECAUTIONS:
