Notification Change

Wilson's Rabbit Repell is a chemical repellent designed to protect trees and shrubs including evergreens from feeding injury caused by rabbits, deer and mice during late fall, winter and early spring when other natural foods are usually covered by snow. The disagreeable taste of RABBIT REPELL discourages nibbling on treated plants after the first bite. RABBIT REPELL is not harmful to wildlife.

DIRECTIONS: Wilson's Rabbit Repell may be applied either directly from the container as a brush-on paint or diluted with equal parts of water for application with a garden pressure sprayer. Treat trees and shrubs in the fall before the first snow fall and when temperature is above freezing. Re-treatment may be necessary during open winters with little or no snowfall or after prolonged winter rains.

SHAKE OR STIR WELL BEFORE USING: Do not allow to freeze. For protection from rabbits and mice, treat the trunk, lower branches and twigs from the soil level to as high as rabbits reach under severe snow conditions. For protection from deer, lightly spray all susceptible areas of plants. Clean brushes and spray equipment thoroughly with water immediately after use. Keep container tightly closed to prevent evaporation.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not use on plant parts that are to be used for food or animal feed. Do not breathe spray mist. Avoid contact with eyes, skin and clothing. Do not contaminate ponds, streams or other bodies of water. Because of unpleasant side effects, alcoholic beverages should be avoided for 24 hours before or after working with this product.

FIRST AID: If on skin, wash with water. If in eyes, get medical attention. If swallowed, induce vomiting and have patient consume milk or white of egg; take patient to hospital.

TOXICOLOGICAL INFORMATION: If reaction with alcohol occurs, treat as disulfuram - alcohol reaction.

DISPOSAL: Do not reuse container. Wrap empty container and discard in household garbage.
