USE DIRECTIONS:

<u>FOR CLEANING</u>: Lightly soiled areas - surfaces to be cleaned should be mopped or brushed with a solution containing 8 mL of Formula A per litre of water. Rinse cleaned area with fresh water. Heavily soiled areas - mop or brush soiled surface with a solution containing 20 mL of Formula A per litre of water. Rinse cleaned surface with fresh water.

<u>GENERAL PURPOSE DISINFECTION</u> *: To disinfect walls, floors, and other hard surfaces in schools, restaurants*, rest rooms and other public areas mop or brush surface to be treated with a solution containing 8 mL of Formula A per litre of water. Surfaces that are heavily soiled should be cleaned with 16 mL of Formula A per litre of water and then disinfected. Those surfaces which may later come in contact with food must be rinsed with clear water of drinking quality. To kill pathogenic fungi in locker rooms, shower stalls, walkways around pools and other areas, mop area with a solution containing 5 mL of Formula A per litre of water. This solution will destroy <u>Trichophyton interdigitale</u>, a causative agent of athlete's foot.

HOSPITAL DISINFECTION **: To disinfect walls, floors, furniture and other hard surfaces in hospitals and nursing homes, mop or brush surface to be treated with a solution containing 16 mL of Formula A per litre of water. Those surfaces that are heavily soiled with blood, fecal material or exudates should be thoroughly cleaned with a solution containing 16 mL of Formula A per litre of water and then rinsed with a fresh solution containing 16 mL of Formula A per litre of water before disinfection.

<u>SANITIZATION</u> ***: To sanitize walls, floors and equipment in food *** processing plants, first clean thoroughly with a solution containing 8 mL Formula A per litre of water. If surface is heavily soiled, use Formula A at a rate of 20 mL per litre to insure thorough cleaning. Sanitize cleaned surface with a rinse solution containing 4 mL Formula A per litre of water. Food contact surfaces must be rinsed with potable water before reuse.

DEODORIZATION: To deodorize surface during cleaning, mop or

brush surfaces with a solution containing 8 mL of Formula A per litre of water, an effective antibacterial cleaner designed for use in industrial and institutional cleaning. It may be relied upon to deodorize bathroom areas,#, garbage pails and other areas where obnoxious odours may develop.
