Kills insects on contact up to 6 metres away. Provides a fogging action over a large area and kills flies, mosquitoes, flying moths, wasps and hornets.

**DIRECTIONS:** Shake before using. **FOR OUTDOOR USE:** For best results spray when air is calm. Allow fog to drift over area. Direct spray toward bushes or grass from at least 1.5 to 2 metres away. Because insects may move in from other areas, treat in area larger than you plan to use. Repeat as necessary. **FOR USE IN GARAGES, COVERED PATIOS:** Direct spray towards ceiling or rafters using a sweeping motion. About 12 seconds of spraying should clear an average area (28 cubic metres). Keep garage closed for 15 minutes. Ventilate sealed area after treatment.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Avoid inhaling spray. Avoid contact with skin, eyes and clothing. Avoid contamination of feed and food. Do not contaminate mangers, drinking troughs or utensils. Cover all food products or remove any uncovered food products in the covered patios or areas to be treated prior to treatment. Cover any food handling surfaces prior to treatment. Wash any food handling surface thoroughly after treatment prior to reuse. Wash after handling or using. This product is highly toxic to fish and aquatic invertebrates. Do not apply directly to or otherwise contaminate ponds, lakes, streams and other bodies of water or water which may be used for irrigation or domestic purposes. Avoid using where drift over aquatic habitats may occur. **CONTENTS UNDER PRESSURE.** Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C.

**FIRST AID:** If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If on skin or clothing: Take off contaminated clothing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If in eye: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Contains petroleum distillates. Treat symptomatically.

**DISPOSAL:** When empty, press button to release pressure, dispose of in household garbage.
