DIRECTIONS FOR USE: Space Spraying: For control of flies, fruit flies, gnats, mosquitoes, wasps, hornets, food and flour moths. Close doors and windows. Apply with sprayer adjusted to deliver a fine mist. Directly spray upwards and uniformly throughout entire area. Ventilate rooms 15 minutes after treatment.

Surface Spraying: To control cockroaches, ants, silverfish, spiders, crickets, clovermites, grain and flour beetles or weevils. Adjust sprayer to deliver a coarse, wet spray. Apply into cracks and crevices, around appliances, behind shelves and drawers and other hiding places. In case of infested foods in cabinets, dispose of the infested materials. Remove all contents and clean thoroughly. Spray interior surfaces & empty cabinets thoroughly. After spray has dried, cover shelves with paper or otherwise protect foods from direct contact with sprayed surfaces. Repeat treatment if reinfestation occurs. For ants, spray trails, nests and points of entry. All sprayed surfaces should be thoroughly wetted.

GARDEN PESTS ON FLOWERS AND ORNAMENTALS: To control aphids, flea beetles, leafhoppers, white flies, spider mites, rose chafers, tarnished plant bugs. Apply a fine mist spray to upper and lower leaf surfaces. Avoid spray drift. Use with caution on young plants and new growth. Repeat treatments weekly or as needed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing

spray mist. Avoid contact with skin, eyes, feed or food. Remove pets, birds and cover or remove aquariums, food and food utensils before spraying. DO NOT USE ON HUMANS OR PETS. Do not apply to draperies, wallpaper or similar materials that may be stained. Do not overwet floors and floor coverings. Do not reuse container. Protect from freezing.

FIRST AID: If in eyes, flush with water; on skin, wash with soap and water. If ingested, do not induce vomiting. Contact a physician or poison control centre immediately.

DISPOSAL: Do not re-use empty container. Discard in household garbage.
