OMEGA is a disinfectant/detergent/fungicide/virucide/odour counteractant. Intended for use in hospitals, nursing homes and related institutions, food and beverage processing, preparation and service institutions, retail, manufacturing, educational and recreational facilities.

OMEGA at a dilution of 4 mL per litre is an effective disinfectant against the following: (at 2 mL/L it acts as a sanitizer):

BACTERIA: Escherichia coli, Klebsiella spp, Proteus vulgaris, Pseudomonas aeruginosa, Salmonella cholerasuis, Serratia marcescens, Shigella flexneri, Staphylococcus aureus.

FUNGI: Aspergillus niger, Candida albicans, Trichophyton interdigitale.

VIRUSES: Canine distemper, Feline pneumonitis, Herpes simplex, Influenza A2 (aichi), Parainfluenza (Sendai), vaccinia.

DIRECTIONS: Prepare an accurate dilution in hot or cold water using Airkem's metering pump. To increase detergent in heavily soiled areas use two strokes. Apply solution to wet surfaces thoroughly with clean mop, sponge, cloth, scrubber or sprayer. Remove solution and suspended soil with clean wet mop, sponge, cloth or wet vacuum pickup. Surfaces subject to food contact must be thoroughly rinsed with potable water.

OMEGA at a dilution of 4 mL/L kills the Human Immunodefiency Virus (HIV) on hard non-porous surfaces.
