Spray to wet the leaves. Do not water lawn for 24 hours after application. Do not cut grass for 4 days before and after treatment. Repeat treatment may be necessary on hard-to-kill or established weeds. *Controls young stage only.

Maximum Application Frequency: For good turf/lawn management, normally two applications per year per treatment site are adequate. This does not include spot treatments. New lawns can be treated after the grass has been cut twice. May cause injury to Bent grass. Do not use or store near heat or flame.
