## DIRECTIONS FOR USE

Use Precautions: Sulphur may burn foliage and fruits during periods of high temperatures and under certain climatic conditions. Reduce rates when applied under warm temperatures. Do not apply when temperatures exceed or are likely to exceed 32 'C or when humidity is high. Do not use Safer's Flowable Sulphur Concentrate with oil or within 30 days of an oil application with foliage sprays. Do not use sulphur on any crop unless local use has proven safe.

Directions for Mixing: Before using, mix container contents thoroughly. Pour recommended amount in partially filled spray tank. Keep agitator running during filling and spraying operation. DO NOT ALLOW MIXTURE TO STAND. Failure to maintain agitation will cause Safer's FLOWABLE SULPHUR to settle and may necessitate manual stirring to redisperse.

The strong adhesive properties of Safer's FLOWABLE SULPHUR act as a sticker on the plant, and the sticking characteristic necessitates the flushing of equipment with water after each day's use. Sulphur in any form is corrosive material. TO REDUCE THE EFFECT, EQUIPMENT SHOULD BE FLUSHED DAILY.

Compatibility: Do not combine with emulsifiable liquids or wettable powders unless previous experience has proven physical compatibility and safety to plants. If tank mixing add Safer's Flowable Sulphur Concentrate to water with the agitator running, then add other pesticides.

Do not apply Safer's Flowable Sulphur Concentrate within 1 day of harvest.

Caution: For scab, brown rot, leafspot and mildew sprays, dilute the product with water applying 4000 L/ha. With Concentrate sprays, use 75% of the recommended active ingredient rate.

If in eyes, flush with plenty of water for 15 minutes and get medical attention.

Storage and Disposal: Store in a cool, dry ventilated place away from food and feed. Freezing temperature -4 'C. Do not re-use empty container and wash thoroughly with water and detergent. Puncture to render container unusable. Dispose of in a safe

place.
