#### DIRECTIONS

## Space Spray:

When used with mechanical and/or thermal fog generator, use solution as is. All animals must be removed from barn/building before fogging. Use to kill flies and mosquitoes. Close all doors and windows and shut off all ventilating systems. Using the spray equipment to dispense insecticide solution as a fine mist, apply at a rate of 325 mL of liquid insecticide per 100 cubic meters of room space. Direct the mist upward to all parts of the room, especially windows and other light sources. Wherever possible keep doors and windows closed for 30 minutes after each treatment. Also direct the mist into areas where insects are present. Do not remain in treated areas. Spray only when temperature is under 32°C.

Ventilate treated areas thoroughly for at least 30 minute before animal re-entry. Following ventilation clean up dead insects. Where the fog or mist have been in contact with food handling equipment, clean such equipment and utensils in accordance with good housekeeping practice before use, and rinse with potable water.

Exposed foodstuffs should be removed from all areas to be treated before treatment.

During the fly season it may be necessary to spray daily. For crawling insects such as cockroaches, grain beetles, spray at least once a week.

For Spot Spraying with a Hand or Electric Sprayer

Use to kill cockroaches, silverfish, fleas, flour weevils, grain beetles, and meal moths. Using the solution as is, apply as directed according to the manufacturer's instructions, using a hand sprayer or electric sprayer. Apply the spray into all cracks and crevices and hiding places, such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Insects must be contacted to be killed. Use at a rate of approximately 325 mL per 100 square meters of room surface. Leave the room closed for 20 to 30 minutes. Do not remain in the treated area.

When spraying animal quarters remove animals from the area to be sprayed and do not spray onto the animals or pets.

### PRECAUTION

This product contains petroleum distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray or mist. Wear protective clothing.
