Do not use on nursing puppies or kittens under 3 months of age. Do not use this or any other pesticide on sick, old or debilitated pets or animals under drug or pesticide treatment. Before using on pregnant animals, consult a veterinarian.

STORAGE AND DISPOSAL: Store in a cool area away from heat and open flame. Store above 0 deg C and protect from freezing. Do not re-use empty container. Wrap original container in several layers of newspaper and discard in trash.
