DIRECTIONS:

Initial shock dosages of 50 to 100 ppm of DEARCIDE 709 are recommended to control bacterial slimes and algae encountered in open recirculating cooling water systems. After control is evident, shock dosages may be reduced to 20 to 50 ppm or applied less often.

CAUTION:
