This product used to control algae, bacteria and fungi in recirculating water cooling towers.

DIRECTIONS FOR USE

Prior to the use of this product in cooling towers, the system should be cleaned to remove algae growth, slime and other deposits. Then make an initial slug addition of 500 to 1,000 mls per 10,000 litres of water in the system. Repeat initial dosage until control is evident. Make subsequent slug additions of 150 to 1,000 mls per 10,000 litres of water every 2 to 5 days. The frequency of addition depends upon the relative amount of bleed off while the quantity per addition depends upon on the potential severity of microbiological fouling. Slug additions should preferably be made in the sump of the tower.

PRECAUTION

KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes or clothing.

FIRST AID:

If swallowed promptly ingest doses of powdered charcoal or a large quantity of milk, egg whites, gelatin solution, gruel, flour or, if these are not available, drink large quantities of water. Then induce vomiting. Avoid alcohol. Keep patient warm. Get IMMEDIATE MEDICAL ATTENTION. If splashed in eyes, flush thoroughly with cool water for 15-30 minutes. For skin contact wash thoroughly with soap and cool water. In case of continued eye or skin irritation get medical attention. Keep container CLOSED when not in use.
