OLYMPIC(R) Wood Preservative Clear is recommended on exterior bare wood surfaces which may be exposed to attack by wood rot, mildew, ultra violet light, or excess moisture. Use it on structural lumber, beams, timbers, sills, millwork and roofs anywhere wood is used above ground and needs extra protection. Wood surfaces treated with Wood Preservative Clear will be protected from moisture damage, mildew and rot, but will still "weather" naturally. For severe exposure to wood rot, pressure treated wood offers maximum protection.

SURFACE PREPARATION: All surfaces must be clean, dry and free of mildew.
