SHAKE WELL BEFORE USE.

INDOORS:

For control of FLIES, GNATS, MOSQUITOES, and SMALL FLYING MOTHS: Close doors and windows and shut off ventilating systems. Using a conventional mechanical or compressed air spraying or fogging equipment, apply as a fog or fine mist directing the spray towards the upper portions of the room and towards windows and other light sources which attract these insects. Thoroughly fill the area with mist using 50 to 100 mL per 100 cubic meters of space. Keep area closed for at least 10 minutes. Vacate after treatment and ventilate before reoccupying. Repeat treatment as needed.

To control WASPS and HORNETS: Direct the spray at these insects when possible. Spray thoroughly into nests, hiding and breeding

places when insects have settled at night.

To control ANTS: Spray trails, nests and points of entry. Spray directly on ants when possible. Repeat as necessary.

To control COCKROACHES, CENTIPEDES, CRICKETS, BOXELDER BUGS, EARWIGS, SPIDERS and SOWBUGS: Apply as a coarse droplet spray directed into cracks, crevices and other hiding places along baseboards, around the base of appliances and cupboards. Spray badly infested areas daily. In other areas, repeat treatments twice weekly or when reinfestation occurs.

INDOORS: ON HOUSE PLANTS AND IN GREENHOUSES

For control of APHIDS, TWO-SPOTTED SPIDER MITES and WHITE FLIES(adult) on the following plants:
