For use as a spot, crack and crevice treatment to control crawling insects listed on front panel.

INDOOR USE: Thoroughly treat cracks, crevices, baseboards, underneath furniture and equipment, around garbage containers and other places where insects habitat.

OUTDOOR USE: Spray outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter.

DIRECTIONS: Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will flow into cracks and crevices for insect control. If reinfestation occurs, repeat applications. Provide adequate ventilation after indoor use.

Remove or cover all food packaging materials, and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before resuming operations. Do not use in rooms where milk is processed, handled or stored.

FIRST AID TREATMENT: Contains volatile petroleum distillate. If swallowed, do not induce vomiting. Call physician immediately. In case of contact with skin, wash with soap and water. If in eyes, flush with water 15 minutes, get medical attention. Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal.
