Ideal for use in bathrooms, locker rooms, public conveyances, kennels, office buildings, schools, restaurants, nursing homes, food processing plants and industrial plants. Use on floor, ceiling, wall table tops, shower stalls, walkways, around pools, bath tubs, sinks, garbage cans, light fixtures, equipment and any other washable surface.

Can be used on terrazzo, marble, ceramic tile, asphalt, vinyl, vinyl asbestos, rubber and other composition floors. Equally effective in soft or hard water containing less than 500 ppm CaCO.

Excellent for use in automatic scrubbing machines. Will not attack normal machine valves, fittings and components. Cleans rapidly and effectively. Rinse completely.

DIRECTIONS

TO CLEAN AND SANITIZE: For light-duty cleaning, sanitizing and deodorizing, dilute product 12mL per 1 litre of water and apply to surface with cloth, sponge or mop.

For sanitizing of previously cleaned food processing equipment and food contact surfaces, dilute product 10mL per litre of water containing less than 500 ppm CaCO. (200 ppm active quaternaries). Rinse thoroughly with potable water.

TO CLEAN AND DISINFECT: For heavy-duty cleaning, general disinfecting and deodorizing, dilute product 30mL per litre of water and apply to surface with cloth, sponge or mop. This dilution will kill *S. aureus*, *S. choleraesuis*, and *Trichophyton interdigitale* on environmental surfaces.

Use 35mL per litre of water to kill. *Pseudomonas aeruginosa*.

Corrosive. Cause skin irritation. Do not get in eyes, on skin or on clothing. Protect eyes and skin when handling concentrate. Harmful if swallowed. Avoid contamination of food. Do not mix with soap or anionic solutions.

FIRST AID

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before re-use. If swallowed, drink milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Call a physician.

TOXICOLOGICAL INFORMATION

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed. Rinse empty container thoroughly with water and discard.
