DIRECTIONS FOR USE:

SPACE SPRAY - Apply at a rate of 100 - 200 millilitres per 100 cubic metres, through a Fogmaster or other similar fog generating equipment. Follow equipment manufacturers directions. For best results, close all doors and windows and shut off ventilating systems during treatment. Remove all animals from treatment area before using as a space spray. Direct spray upwards to all parts of the room, especially windows and other light sources. Also direct mist into areas where insects are present. Spray only

when temperature is under 32 degrees C. Keep area sealed for 30 minutes after each treatment. Do not remain in treated areas. Ventilate treated areas thoroughly for at least 30 minutes before animal re- entry. Ensure proper ventilation after sealed areas have been treated. Following ventilation, clean up dead insects.

LIVESTOCK SPRAY - To treat dairy cattle and horses against stable flies, horse flies and mosquitoes, spray animal once only daily with a fine mist, using either a continuous hand operated spray or a Fogmaster on the lowest setting. Spray at a rate of 30 to 45 millilitres per animal, being careful to wet ends of hair only. Do not wet hair or skin. Avoid spraying in animal's eyes. Treat dairy cattle before milking. Wash udder before milking. Do not use more often than once a day.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Flammable mixture. Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water or food stuffs. In food processing plants and food service establishments, apply only when plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operations. Do not use in milk processing plants or milk parlours. Keep out of reach of children. Do not use near birds, fish or pets. Do not spray closer than 1 m to fabric. Dispose of container in regular garbage.

FIRST AID: Product contains Petroleum Distillate, if swallowed DO NOT induce vomiting. Obtain medical attention immediately. If in eyes, flush with plenty of water. If on skin, wash with soap and water. If irritation persists, obtain medical attention.
