READ ENTIRE LABEL BEFORE USING PRODUCT.

MAX-15 is a formulation which provides rapid kill and long residual action against the following insects: Ants, Crickets, Flies (outdoors only), Cockroaches, Sowbugs, Brown Dog Ticks, Earwigs, Millipedes, Spiders, Clover Mites, Fleas (outdoors only), Mosquitoes (outdoors only), Silverfish and Saw Toothed Grain Beetles (exposed stage).

DIRECTIONS FOR USE: MAX-15 emits a small direct spray to a distance of 2 metres. Cracks, crevices and hard-to-reach locations can easily be treated without bending, crawling, or climbing. Treat the surfaces until wet, moving the spray stream rapidly to prevent excessive wetting and waste of material. Do not point the spray toward people, plants or pets.

INDOOR APPLICATION: For use in non-food areas only. Ants, cockroaches, crickets, spiders, saw toothed grain beetles (exposed stage) and silverfish: Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, sinks and in and around waste containers. For ants, spray trails and places where ants enter premises. Do not treat foodstuff or house plants. Remove pets and cover fish bowls or exposed food before spraying. Do not allow children or pets to contact treated surfaces until the surfaces are completely dry. Repeat as necessary.

Brown Dog Ticks: Spray sleeping quarters of pets and around baseboards, window frames and door frames, wall cracks and local area of floor. Repeat as necessary. Fresh bedding should be placed in animal quarters after spraying. Do not treat animals.

OUTDOOR APPLICATION: Ants, clover mites, crickets, earwigs, fleas, flies, millipedes, mosquitoes, sowbugs and brown dog ticks: Treat infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios or other places where insects may enter. For ants, treat hills and runways. Repeat when necessary. Do not spray vegetation.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Do not spray near open flames or sparks. Do not contaminate food, beverages, utensils or food preparation surfaces. Do not apply to drapes, wallpaper, carpets, rugs or similar materials that may be stained. Avoid excessive wetting of rubber, plastic and asphalt surfaces such as tiles and floor coverings. Do not use on humans, plants, animals, food stuff, food utensils, fish bowls or animal feed areas.

Do not use as a space spray. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing. Avoid breathing the spray mist and provide adequate ventilation of area being sprayed.

FIRST AID TREATMENT: Contains volatile petroleum distillate. If swallowed, do not induce vomiting. Call a physician or a poison control centre immediately.

In case of contact with the skin, wash with soap and water. If in eyes, flush with water for 15 minutes, get medical attention. Take container, label or product name and Pest Control Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Propoxur is a mild cholinesterase inhibitor.

Atropine is antidotal.

DISPOSAL: When container is empty, press valve to release all remaining pressure.

Dispose of empty container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer. Do not puncture or incinerate.
