For use as a spot or crack and crevice treatment to kill

spiders, sowbugs, earwigs, cockroaches, crickets, millipedes, silverfish, ants, fleas, carpet beetles, brown dog ticks.

INDOOR USE: Thoroughly treat cracks, crevices, baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings (spot treatment only) and other places where insects occur.

OUTDOOR USE: Spray outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter.

DIRECTIONS: Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestations occur, repeat application. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50 deg C. Do not spray near open flame or spark or while smoking. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOODSTUFF, FOOD UTENSILS, FISHBOWLS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. DO NOT CONTAMINATE FOODSTUFFS. Do not use in any area where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboards where food or cooking utensils are stored. In homes, or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before re-use.
